Mooi River Fire Protection Association is a registered fire association with the Department of Water Affairs and Forestry in terms with section 4(2) of the National Veld Fire act 101 of 1998.

Amongst the benefits of membership of a Fire Protection Association are:

- The presumption of negligence (i.e. if a landowner is a member of the Association, he/she will be presumed **innocent** of negligence until proven guilty).
- An official Fire Protection Officer has been appointed to enforce The Act.
- The assistance of the Mooi River Fire Protection Association and its members in the event of a run- away fire.
- Non-membership of the Association precludes co-ordinated fire protection in a high-risk area
- Use of equipped firefighting trailer for firebreaks.

Registration Fee (Payable once only) R100-00 Per landowner or lessee

Annual Membership dependent on property size and risk rating decided at the AGM in May 2026 with a minimum subscription fee of R1200.00 per entity.

Regardless of the number of properties owned or leased, there will be a once off registration fee and then an annual membership fee. At present we are not charging Vat on either the registration or membership fee, as registration in this regard has not been finalised.
